In 2014, we cared for 2,155 animals until they could be returned to their owners or appropriate homes could be found for them. We joyfully reunited 435 pets with their owners and we placed 1,252 pets in new homes. Our commitment to not euthanize for space led to 245 pets being transferred to other no-kill shelters and rescues around the state.
