4a (Code:) (Expenses \$ 812,310. including grants of \$) (Revenue \$ 246,555.) Blue Mountain Humane Society's 49th year was full of exciting accomplishments. In 2016 we cared for 2,275 animals. We reunited 589 pets with their owners and found new homes for 1,356 pets during the year. Our foster program was expanded to include 325 pets, preventing overcrowding and relieving the stress that many animals experience in the shelter setting. We started a program to provide group play sessions for shelter dogs, resulting in calmer, quieter kennels and training breakthroughs for some dogs. We make every effort to keep pets and their people together, and partner with others to deliver pet food and supplies weekly to the families of 49 dogs, 62 cats, and 1 bird, easing the financial burden of animal ownership for families in need. We are proud of the progress the Society continues to make as we move
