Foster families opened their homes to 524 pets. We cared for 3,089 animals and achieved a 97.5% Live Release Rate, maintaining our No-Kill Shelter status. Three hundred sixty-eight people volunteered at BMHS, investing 10,737 hours in service. We returned 498 lost pets to their loving homes. We responded to 325 Animal Control calls in Walla Walla County. We took in 514 pets from other shelters, knowing they would find their forever homes in the Walla Walla Valley.
